Why do you consider that the draft Chigwell Neighbourhood Plan and/ or supporting documents do/ do not meet the specified "basic condition"? Please provide a brief summary of your comments.

This is for "a. having regard to national policies and advice contained in guidance issued by the Secretary of State it is appropriate to make the order (or neighbourhood plan)."

Both national policies and advice are poorly defined and quite wrong. Both Order and Neighbourhood Plan do not meet this specific basic condition at all.

Both Order and Neighbourhood Plan do not take Chigwell and its needs into account properly.

Chigwell is well over-developed and is containing very few local open spaces which are in danger of being allocated for development, in order to satisfy Secretary of State's rather than local residents' needs. Those local open spaces left in Chigwell are very precious to local residents as it has been that way for many years.

Why do you consider that the draft Chigwell Neighbourhood Plan and/ or supporting documents do/ do not meet the specified "basic condition"? Please provide a brief summary of your comments.

This is for "c. having special regard to the desirability of preserving or enhancing the character or appearance of any conservation area, it is appropriate to make the order. This applies only to Orders."

Both Chigwell Neighbourhood Plan and Epping Forest DC's Local Plan do not meet this specified basic condition because they support/encourage the removal of few precious remaining local open spaces in Chigwell (so to support unwanted and unnecessary development on those).

It is clear that both Epping Forest DC's Local Plan and Neighbourhood Plan do not care for lower socio-economic/less well-off groups which made up of Limes Farm's population. Those plans encouraged development on few open spaces within Limes Farm area at the expense of the local population. If those open spaces were removed for development, there will be NO open space for the local population. Both plans penalise the local population by removing their access to local open spaces because of their lowly status as lower social-economic/less well-off groups.

This is for "d. the making of the order (or neighbourhood plan) contributes to the achievement of sustainable development."

Both Order and Chigwell Neighbourhood Plan do not meet the specified "basic condition" because they do not support nor contribute any to achievement of sustainable development. Chigwell is overdeveloped and it is simply not sustainable to develop or build any more additional home in Chigwell.

Why do you consider that the draft Chigwell Neighbourhood Plan and/ or supporting documents do/ do not meet the specified "basic condition"? Please provide a brief summary of your comments.

Chigwell Neighbourhood Plan (and Epping Forest DC's local plan) does not meet this specified "basic condition" because those are in breach of EU regulation, and laws especially the urban green space/public space.
