- 1.1 With an Historic town (Chipping Ongar) within its civil area, an Ancient Monument, the oldest wooden church in the world (at Greensted), two conservation areas and many Listed Buildings as well as being located in Green Belt with Landscape Characterisation as sensitive to change, Ongar would welcome the Development Management Policies to include more of the supporting text to the Policies to ensure that Heritage Assets and Landscape Character is better protected.
